I. Call to Order:

At 6:00PM with a quorum present the Chairman, Cmr. Morrow, called the meeting to order.

- II. Adopt Minutes: The Chairman made a request to entertain a motion to accept the minutes from the Airport Authority Meeting held on 14 October 2013. Cmr. Raymond Ray motioned to approve the minutes, Mr. Larry Johnson seconded. The motion was approved (5-0).

a. Property Acquisition Update (Current Airfield):

McLendon Property Phase II Environmental Survey complete. Awaiting GDOT Review Appraisal before making offer to property owner, should be done in December.

AD updated the Authority on items and cost estimates (see attached). Discussion resulted in a formal resolution to be drafted & approved at the Dec 9^{th} Authority Meeting

c. AIP Update – Tree Removal & Avigation Easements:

AD briefed on problems arising from AIP 29 request for permissions from land owners regarding obstruction (tree) removal process. Recommends obtaining avigation easements if current location is to be permanent.

d. 5 Year CIP Review (Due to GDOT 31 Dec 2013):

Authority discussed 5 yr. CIP based upon AD & Consultant long range planning. Authority will review draft for approval at the Dec 9th Authority Meeting.

AD reported that both Finance & Personnel Dept.s are drafting agreements. Will have CFO address at the Dec 9th Authority Meeting.

AD outlined his discussion with GDOT & FAA personnel at GAA Conference, GDOT verbalized some items they would like to discuss prior to decision. Authority instructed AD & Consultant to prepare a pre-brief for Authority members at a date to be determined before setting GDOT meeting date.
